NOTES TO TABLE 1:

- 1. Country reports are generally obtained from websites of national agencies. These reports in some cases do not provide complete information.
- 2. For The Bahamas, the number of deaths in the table excludes **67 deaths** that are under investigation and **131 deaths** that are classified as due to non-COVID-19 causes of COVID-19 positive persons. The total number of deaths of COVID-19 positive persons is **855**.
- 3. For Jamaica, the number of deaths in the table excludes **339** deaths that are under investigation and **188** deaths that are classified as coincidental. The total number of deaths of COVID-19 positive persons is **2801**.
- 4. Generally, the total doses administered can be obtained by adding the sum of the first and second doses for the respective countries, but this is not always the case. As shown in the table the percentage of persons fully vaccinated is given as a percentage of the total population and not of the target population, which may vary across countries, such as the 12+ or 18+ population. In addition, the estimated population was obtained from the United Nations Population Division and may differ from the country estimate.
- 5. While every effort was undertaken to present data as at Friday 5 November, for a few countries the data are as at 1-3 November, 30 October in the case of Haiti and 6 October in the case of the British Virgin Islands.

DATA HIGHLIGHTS ON NUMBER OF CONFIRMED CASES (Tables 1 and 2)

- The total number of confirmed cases, all countries stood at 378,186 as at 5 November 2021 and was approximately 1.1 times the figure on 8 October 2021, which was 336,735 (an increase of 12.3 percent).
- For Member States, the number of confirmed cases reflected a similar change as for all CARICOM countries with the total number of cases moving to **363**, **058** on 5 November as compared to **324**, **115** on 8 October (**1.1** times, or **12** percent increase).
- For the Associate Members, the number of confirmed cases moved to 15,128 on 5 November or 1.2 times the number of cases on 8 October (19.9 percent increase), which was 12,620.
- Relatively high increases were reflected for the following countries:
 - Cayman Islands 2676 as at 5 November which was 2.8 times the figure of 8 October, which was 960, or an increase of 178.8 percent;

- Anguilla 1039 as at 5 November which was 1.9 times the figure as at 8 October 544,
 or an increase of 91 percent;
- October, **10,383**, or an increase of 88 percent;
- In terms of the number of cases per 100, 000 population, the countries with the highest rates were: British Virgin islands with **9,347.88** followed by Bermuda with **8,874.06** and Suriname with **8,491.25**. Turks and Caicos Islands with **7,290.56**, Barbados, **7106.21**, Saint Lucia with **7088.27** and Belize **7007.66**;
- In nominal terms, Jamaica had the highest number of confirmed cases at **89,587** followed by Trinidad and Tobago with **58,581** and Suriname with **49,504**. Guyana had the fourth highest number of confirmed cases with **35,993**, Haiti, Belize and The Bahamas all have over 20,000 confirmed cases.

HIGHLIGHTS COVID-19 DEATHS

- Countries with the highest death rates per 100,000 population as at 5 November 2021 were (Table 4):
 - Suriname with 190.74, Grenada with 177.63 and The Bahamas with 172.3. Bermuda with 165.69, Saint Lucia, 145.25, Trinidad and Tobago with 128.97, Belize with 127.87, British Virgins Islands with 126.93, Guyana with 125.91;
 - St Vincent and the Grenadines had an increase in the number of deaths from 33 as at 8 October to 69 on 5 November 2021, or 109.1 percent;
 - Barbados had an increase in the number of deaths from 100 as at 8 October to 170 on 5 November 2021, or 70 percent;
- The Case Fatality rates (Table 5) ranged from **0.1** percent (Anguilla) to **3.4** percent (Grenada). The case fatality rate measures the number of deaths per COVID-19 Confirmed Cases.
